

MINUTES OF MEETING HELD 3rd.JUNE 2007 1300hrs AT COSTA RICA BAR

THIS MEETING WAS CALLED TO ESTABLISH THE WAY FORWARD AFTER THE AGM HELD 29TH.APRIL 2007 AT THE LANTERN.

ALL OF THE PRESENT COMMITTEE STOOD DOWN BECAUSE IT WOULD REQUIRE TWO COMMITTEES TO BE FORMED, ONE FEDERATION AND ONE NON FEDERATION. THE NON FEDERATION LEAGUE HAVE NOW STARTED TO ORGANIZE THEMSELVES SO THAT THE LEAGUE CAN CONTINUE AND GROW.

AT THE AGM, IT WAS PROPOSED AND SECONDED THAT THE CHAIRMAN, VICE CHAIRMAN AND SECRETARY FOR THE PAFOS DARTS LEAGUE WOULD BE THOSE LISTED ABOVE. THIS SHOULD HAVE BEEN RECORDED IN THE MINUTES AS REQUESTED BY BERNARD DANGERFIELD AT THE TIME.

FORWARD.

ALAN WALKER WAS CO- OPTED TO THE NEW COMMITTEE.

1) IT WAS DECIDED THAT THE LEAGUE WILL CONTINUE TO PLAY ON A TUESDAY NIGHT ARRIVING AT 1930 FOR A 2000 START.

2) THE COMMITTEE WILL PAY VISITS TO PUBS AND CLUBS TO SEE IF THEY WISH TO JOIN THE LEAGUE AND WILL DISTRIBUTE POSTERS AND POSSIBLY FLYERS TO ADVERTIZE FOR PLAYERS AND TEAMS.

3) THE COMMITTEE WILL APPROACH THE FREE PAPERS; SCOOP, GRAPEVINE ETC AS WELL AS THE CYPRUS MAIL. TO PUBLICIZE THE LEAGUE.

4) IT WAS FELT THAT THE LEAGUE WAS NOT YET READY FOR THE FEDERATION AND THAT AN EMAIL SHOULD BE SENT TO THE FEDERATION TO CLARIFY A FEW POINTS. WE SHOULD TRY TO ENTER INTO DISCUSSIONS WITH THEM TO FIND A COMPROMISE SO THAT MEMBERS WOULD NOT BE DEPRIVED OF THE HONOUR OF REPRESENTING PAFOS OR CYPRUS IN COMPETITIONS

5) IT WAS DECIDED THAT THERE SHOULD BE BUSINESS CARDS WITH ALL OF THE COMMITTEE'S NAMES AND PHONE NUMBERS PRINTED ON THEM.

6) A LIST OF TEAMS THAT HAVE APPLIED TO JOIN THE LEAGUE TO BE FORWARDED TO THE COMMITTEE BY THE SECRETARY.

7) IT WAS DECIDED THAT THE DECISIONS MADE AT THE MEETING HELD 23RD.APRIL WILL BE REVIEWED BY THE NEW COMMITTEE.

8) A COMMITTEE MEETING WILL BE HELD ON THE 12TH.JUNE AT 1930 AT THE FISHING SHACK, TO BE CONFIRMED, TO DECIDE ON THE RULES OF THE LEAGUE.

9) AFTER THEIR SUCCESS IN TENERIFE, JOHN LOWE AND ERIC BRISTOW ARE LOOKING FOR ORGANISATIONS TO STAGE CHARITABLE DARTS EVENTS WORLDWIDE AND IT WAS DECIDED TO SEE IF IT WAS POSSIBLE FOR THE PAFOS DARTS LEAGUE TO HOLD A FUNCTION AT THE AMBASSADOR RESTAURANT IN PAFOS.
