MINUTES OF LAST MEETING.

ACCEPTED.

STEERING COMMITTEE.

DAVE FRANKLIN DECLINED THE OFFER TO JOIN THE COMMITTEE AND AN EMAIL HAS BEN SENT TO ALL TEAMS REQUESTING VOLUNTEERS.

REGISTRATION AND APPLICATION PROGRESS.

REGISTRATIONS RECEIVED FROM THE FROG & TOAD 'A', COSTA RICA BAR AND THE PHOENIX CLUB SINCE LAST MEETING.

APPROACHES HAVE BEEN MADE TO HEALS BAR, HOUSE OF BLUES, LATIN CLUB, LATIN PARISH, 'O'BAR, SEA HORSE, THE ROSE, MEMORIES, AND THE CRAZY SPOON ALL GIVING A POSITIVE RESPONSE.

ZORO'S AND THE NEW HORIZON PUB WILL NOT BE ABLE TO RAISE A TEAM AND WE ARE WAITING FOR A RESPONSE FROM THE JAIL HOUSE, JASPERS, KEG & BARRELL, MONTI LEO (CHLORAKA), O'NEILS, THE PUB PUB, THE RAILWAY (CHLORAKA), THE SPORTS BAR, AND THE WINE LODGE. IT WAS DECIDED TO EMAIL THE TEAMS THAT HAVE REGISTERED AT A LATER DATE TO ASK FOR THEIR OPPINIONS.

THE LEAGUE CUP WILL REMAIN IN THE PRESENT FORMAT.

SHOULD A REVISED FORMAT BE AGREED TO BE ADOPTED FOR THE HIGHER LEAGUES WHEN A TEAM PLAYS A FRIENDLY THEY MAY PLAY RULES THAT ARE MUTUALLY AGREED BETWEEN BOTH SIDES BUT IN THE CASE OF DISPUTE THE LOWER TEAM MATCH FORMAT WILL APPLY.
