**IT WAS PROPOSED THAT THE END OF SEASON COMPETITIONS BE  
LADIES SINGLES,MENS SINGLES AND DOUBLES.(MIXED OR  
OTHERWISE)**

**THIS WAS ACCEPTED BY THE MEETING.**

**THE NUMBER OF LEGS,IN HOUSE,TO DETERMINE THE TWO  
QUALIFIERS FROM EACH PUB OR CLUB WILL BE AT THE  
DISCRESSION OF THE PUB OR CLUB WHERE PLAYED.**

**THE COMPETITION TO DETERMINE THE FOUR SINGLES OR PAIRS TO  
PROGRESS TO FINALS NIGHT WILL BE ONE LEG FOR 32 DOWN TO 16,  
ONE LEG FROM 16 TO 8 AND THREE LEGS FROM 8 TO 4.**

**ON FINALS NIGHT THE SEMI-FINALS WILL BE BEST OF THREE AND THE FINALS WILL BE BEST OF FIVE.**

**THE IN HOUSE COMPETITIONS WILL TAKE PLACE 20<sup>TH</sup>.MARCH AND RESULT SHEETS AND MONEY COLLECTED,50c FOR EACH COMPETITION ENTERED, MUST BE HANDED IN TO COCKATOOS BY 22<sup>ND</sup>.MARCH FOR THE ATTENTION OF VIC HEMMING.**

**THE LADIES SINGLES QUALIFIERS WILL PLAY THEIR MATCHES TO DETERMINE THEIR FINALISTS AT THE CORAL BAY VENUE ON 27<sup>TH</sup>.MARCH AND SHALL REGISTER AT 19.30 FOR A 20.00 START.**

**THE MENS SINGLES QUALIFIERS WILL PLAY THEIR MATCHES TO DETERMINE THEIR FINALISTS AT THE LATIN PARISH ON 3<sup>RD</sup>.APRIL AND SHALL REGISTER AT 19.30 FOR A 20.00 START.**

**THE DOUBLES QUALIFIERS WILL PLAY THEIR MATCHES TO DETERMINE THEIR FINALISTS AT CHARLIES BAR 10<sup>TH</sup>.APRIL AND SHALL REGISTER AT 19.30 FOR A 20.00 START.**

**THE FINAL WILL BE PLAYED,SUBJECT TO CONFIRMATION,AT THE AMBASSADOR RESTAURANT ON 17<sup>TH</sup>.APRIL 19.30 FOR 20.00 START.**

**IT WAS PROPOSED THAT MEETINGS WILL BE HELD AT DIFFERENT VENUES.**

**B)**

**THE QUESTION OF A DISPUTED RESULT SHEET WAS RAISED.**

**IT WAS AGREED THAT ONCE BOTH CAPTAINS HAD SIGNED THE SHEET THAT THE RESULT WOULD STAND.**

**THE PROCEDURE FOR DEALING WITH A DISPUTED RESULT WILL BE COVERED IN THE NEW RULES TO BE ADOPTED.**

**C)**

**ERRORS IN SCORING.**

**EACH TEAM WILL BE RESPONSIBLE FOR NOMINATING A CHECKER FOR EACH GAME.**

**FROM 170 DOWN THE LAST SCORE AND THE PREVIOUS BALANCE SHOULD BE STRUCK THROUGH TO LEAVE THE BALANCE REQUIRED ONLY AND MUST BE EXPRESSED AS eg. 32 AND NOT 2x16.**

**D)**

**AT THE PREVIOUS MEETING IT WAS DECIDED TO HAVE POSTERS AND FLYERS PRINTED TO PUT ROUND PUBS AND CLUBS IN THE DISTRICT AND CHARLES TURRALL WOULD ASK LORRAINE OF ANY PROGRESS.**

**E)**

**THE CURRENT GAMES FORMAT OF TWO FOURS, FOUR PAIRS AND EIGHT SINGLES BEST OF ONE FRAME WAS CHALLENGED TO BE CHANGED TO TWO PAIRS AND EIGHT SINGLES BEST OF THREE.**

**THIS WAS DEFEATED.**

**IT WAS PROPOSED THAT THE POINTS SYSTEM BE CHANGED TO A TEAM BEING AWARDED THE POINTS THEY WON ON THE NIGHT WITH AN ADDED BONUS FOR A WIN OR DRAW ADDED TO THAT SCORE.**

**THE COMMITTEE WAS ASKED TO CONSIDER THIS AT THEIR NEXT MEETING.**

**G)**

**IT WAS ESTIMATED THAT THERE COULD BE TWENTY OR MORE TEAMS IN THE NEXT SEASON AND THAT PRIORITY WILL BE GIVEN TO THOSE EXISTING TEAMS IN THE FORMATION OF LEAGUES.**

**A COMMITTEE MEETING WILL BE HELD AT 20.00 AT CHARLIES BAR 24<sup>TH</sup>.APRIL TO DISCUSS THE FINALS NIGHT AND TO CONSIDER THE RULES FOR THE NEXT SEASON.**

**RULES.**

***LEAGUE COMPETITION.***

**THE LEAGUE SHALL BE SPLIT INTO TWO DIVISIONS (DIVISION 1 AND DIVISION 1A)**

***FIXTURES.***

**ALL GAMES WILL BE PLAYED ON A TUESDAY NIGHT AS PER PRE DETERMINED FIXTURE LIST WITH TEAMS ARRIVING AT 19.30 FOR 20.00 START.**

***PLAYERS.***

**A MINIMUM NUMBER OF PLAYERS TO MAKE A MATCH WILL BE SIX BUT IF A TEAM IS SHORT THEY CAN BORROW FROM THE TEAM THEY ARE PLAYING OR CAN USE VISITING FRIENDS OR RELATIVES. THEY CAN NOT USE PLAYERS FROM OTHER TEAMS.**

***A TEAM WITH LESS THAN EIGHT PLAYERS.***

**THE TEAM MAY PLAY THEIR FOURS WITH REDUCED PLAYERS THUS IN THE CASE OF A TEAM PLAYING ONLY SEVEN PLAYERS ONE FOUR WOULD BE PLAYED WITH THREE PLAYERS AGAINST FOUR AND HAVE NINE DARTS PER ROUND AND THEIR OPPONENTS WOULD HAVE TWELVE DARTS PER ROUND.**

**ONE DOUBLES GAME WOULD BE FORFEITED BUT THE OPPOSING PLAYERS NOMINATED TO PLAY THE FORFEITED GAME WILL NOT HAVE A WIN CREDITED TO THEIR STATISTICS.**

**THE TOTAL NAMES OF THE TEAM WITH LESS THAN EIGHT PLAYERS WILL BE DRAWN TO DECIDE THE ORDER OF THE SINGLES AND THEN DRAWN AGAIN TO ESTABLISH WHICH PLAYER OR PLAYERS WILL PLAY A SECOND SINGLE'S MATCH.**

***TEAM FORMATION.***

**THE MAXIMUM PLAYERS A TEAM MAY FIELD IS TWELVE.**

***STARTING A MATCH.***

**THE START OF A MATCH WILL BE DETERMINED BY THE TOSS OF A COIN AND THE WINNER CAN DECIDE IF THEY WISH THEIR TEAM OR**

**THE OPPOSITION TO START AND THEN EACH GAME WILL BE STARTED ALTERNATELY.**

***SCORING.***

**THE HOME TEAM WILL PROVIDE A CHALKER AND CAN IF DESIRED ALSO HAVE A CALLER AND ONE PLAYER FROM THE OPPOSING SIDE MAY CHECK THE SCORES AND CALL FOR A CHECK SHOULD THEY FEEL AN ERROR HAS BEEN MADE.**

***REMOVAL OF DARTS.***

**DARTS MAY NOT BE REMOVED FROM THE BOARD UNTIL THE SCORE HAS BEEN VERIFIED.**

***TRANSFERS.***

**A PLAYER MAY TRANSFER FROM ONE TEAM TO ANOTHER PROVIDING THEY HAVE A RELEASE FORM SIGNED BY THEIR EXISTING CAPTAIN,OR LANDLORD IF THE CAPTAIN IS INVOLVED. A PLAYER MAY BE REFUSED A TRANSFER SHOULD IT BE FELT THAT THE PLAYER HAS BEEN APPROACHED BY ANOTHER TEAM TO PLAY FOR THEM AND THE PRESIDENT SHOULD BE INFORMED, UNTIL A COMMITTEE IS FORMED, AND ACTION WILL BE TAKEN AGAINST THE OFFENDING TEAM SHOULD IT BE PROVEN.**

***PLAYERS & SUPPORTERS BEHAVIOUR.***

**IT WAS STATED THAT EACH TEAM WOULD BE RESPONSIBLE FOR ITS PLAYERS AND SUPPORTERS BEHAVIOUR AND THAT ANY PLAYER FOUND TO BE NOT BEHAVING IN THE SPIRIT OF THE LEAGUE WILL BE BANNED.**

***ORDER OF PLAY.***

**2 x FOURS. - 801**

**4 x PAIRS. - 601**

**BREAK FOR REFRESHMENTS.**

**8 x SINGLES. - 501**

***DRAWING OF GAMES.***

**FOURS AND PAIRS.**

**EACH CAPTAIN WILL SELECT THEIR TEAMS AND THESE WILL BE DRAWN AT RANDOM TO DECIDE WHICH TEAM WILL PLAY ONE FROM THE OPPOSING SIDE.**

**SINGLES.**

**EACH CAPTAIN WILL SELECT THE EIGHT PLAYERS THEY WISH TO PLAY IN THE SINGLES AND THESE WILL BE DRAWN AT RANDOM TO DETERMINE THE ORDER OF PLAY.**

***MATCH RESULT.***

**3 POINTS - WIN.**

**1 POINT - DRAW.**

***CANCELLATION.***

**A MINIMUM OF 24 HOURS NOTICE MUST BE GIVEN FOR ANY MATCH TO BE CANCELLED.**

**ANY TEAM THAT CANCELS A MATCH NO MATTER WHAT THE REASON WILL FORFEIT THE MATCH AND THE OPPOSING TEAM WILL BE AWARDED THE POINTS.**
