5) CHALLENGE MATCHES

WE HAVE HAD A REQUEST FOR AN INFORMAL MEETING WITH THE LIMASSOL DARTS ASSOCIATION WITH A VIEW TO ORGANIZING MATCHES BETWEEN OUR TWO AREAS.

WE DO NOT AS YET KNOW ANY DETAILS OR FORMAT SO IT WAS DECIDED THAT THE FOLLOWING SHOULD BE DONE TO PREPARE OURSELVES PRIOR TO THE MEETING :-

1) ASK FOR APPLICATIONS TO BE INVITED FOR CAPTAIN AND VICE CAPTAIN FOR THREE TEAMS,

MEN'S "A" TEAM (1ST DIVISION)

LADIES TEAM

LEAGUE "B" TEAM (2ND/3RD DIVISION)

2) A NON PLAYING MANAGER TO COVER ALL THREE TEAMS

THIS WILL BE DONE WHEN THE LEAGUE TABLES ARE PUBLISHED FOR W/E 8TH. FEBRUARY AND WILL ALSO ASK FOR PLAYERS WHO WISH TO BE CONSIDERED FOR SELECTION.

AS AGREED AT THE LAST MEETING ANY ONE REPRESENTATIVE TEAM MAY ONLY HAVE A MAXIMUM OF TWO PLAYERS FROM ANY TEAM.

6) JOHN LOWE

WE HOPE TO NEGOTIATE THE PRICE OF DRINKS AT THE AMBASSADOR RESTAURANT AT 2 EURO FOR A LARGE BEER AND 2.50 EURO FOR A SPIRIT WITH MIXER, THIS WILL BE CONFIRMED SOON. WINE WILL BE AVAILABLE BY THE BOTTLE WITH THE PRICE LIST DISPLAYED IN A PROMINENT POSITION.

PAPHOS TV HAVE BEEN CONTACTED FOR THEM TO VISIT THE AMBASSADOR TO CHECK OUT THEIR LIGHTING REQUIREMENTS.

THOMAS COOK ARE TO CONFIRM FINAL HOTEL ACCOMMODATION. THEY WILL ALSO INFORM US OF THE FLIGHT DISCOUNT IN EURO VOUCHERS THEY PLAN TO DISTRIBUTE TO THOSE BUYING A TICKET WHICH WAS £20 AND THEIR IDEA OF PLAYERS WHO BEAT JOHN BEING PUT INTO A DRAW FOR RETURN TICKETS TO THE UK.

SIXTY RAFFLE TICKETS ARE TO BE DISTRIBUTED TO ALL TEAMS SO THAT THESE MAY BE SOLD BEFORE THE EVENING. TICKET STUBS WITH MONEY AND ANY UNSOLD TICKETS MUST BE RETURNED

19TH.FEBRUARY TO COCKATOO'S BOWLING CENTRE FOR THE ATTENTION OF VIC.

7) *STAGE EXTENSION AT THE AMBASSADOR*

TO ENABLE THE OCHE TO BE AT THE SAME LEVEL AS THE STAGE IT HAS BEEN DECIDED THAT A STAGE EXTENSION SHOULD BE MADE TO AVOID THE STEP UP THAT WE HAD LAST YEAR AND WORK HAS STARTED WHICH WILL BE COMPLETED 9TH.FEBRUARY. THE MOVEABLE EXTENSION WILL BE KEPT AT THE AMBASSADOR RESTAURANT AND WILL BE USED FOR ANY DARTS EVENT WE HAVE THERE.

8) *SURROUND AND BOARDS.*

FOUR SURROUND DELIVERED TO KEO 4TH.FEBRUARY. GEORGE PANTELI WAS ON HOLIDAY UNTIL 5TH.FEBRUARY AND A MESSAGE REQUESTING A MEETING WITH HIM WAS LEFT. IF NO CONTACT MADE BY 7TH.FEBRUARY THEN WE SHALL CALL HIM.

9) *BANK ACCOUNT*

10) *INDIVIDUAL/PAIRS COMPETITIONS.*

APPLICATION FROM VENUES WILL BE REQUESTED WHEN THE LEAGUE TABLES FOR 5TH.FEBRUARY ARE SENT OUT. A VENUE MUST HAVE TWO BOARDS WITH A REASONABLE DISTANCE BETWEEN THE TWO AVOID ONE BOARD DISTRACTING THE OTHER.

11) *AOB*

THERE WAS A COMMENT MADE THAT SOME PLAYERS ARE NOT BEHAVING IN A SPORTSMANSHIP LIKE MANNER AND ALL CAPTAINS ARE TO BE REMINDED THAT THEY ARE RESPONSIBLE FOR THE BEHAVIOUR OF THEIR TEAM.
