#### **4) JOHN LOWE VISIT.**

ADVERTS CARRIED IN THE CYPRUS MAIL, PAPHOS TIMES, PAWS MAGAZINE, PAPHIAKOS WELFARE MAGAZINE PLUS BROADCASTS ON BFBS AND ROCK FM.

FLIGHT INFORMATION SENT TO JOHN LOWE BUT UNABLE YET TO CONFIRM HOTEL.

ANY REGISTERED PLAYER THAT PURCHASES A TICKET WILL BE ELIGIBLE TO PLAY JOHN BUT MUST INFORM THEIR CAPTAIN WHO WILL FORWARD THEIR DESIRE TO THE LEAGUE SECRETARY BEFORE THE NIGHT.

THE NAMES OF EIGHT OF THOSE WISHING TO PLAY JOHN WILL BE DRAWN ON THE NIGHT WITH A CHANCE FOR THOSE NOT DRAWN OUT TO PLAY JOHN BEING SUCCESSFUL IN THE AUCTION FOR THE REMAINING TWO PLACES.

***TEAM CAPTAINS WERE REQUESTED TO ENCOURAGE ONLY PLAYERS WHO WILL NOT EMBARRASS THEMSELVES ON THE NIGHT IN THE INTEREST OF SEEING GOOD DARTS . HOWEVER NO REQUEST WILL BE TURNED DOWN FROM ANY REGISTERED PLAYER WHO HAS BOUGHT A TICKET.***

#### **5) LEAGUE PROGRESS**

THE LEAGUE NOW HAS 321 MEMBERS.

ON VISITS TO PUBS AND CLUBS THE GENERAL CONSENSUS OF OPINION IS THAT OUR MEMBERS ARE ENJOYING THEIR DARTS AND ARE MAINTAINING THE AIM OF THIS LEAGUE WHICH IS “ TO FOSTER FRIENDSHIP BETWEEN PUBS AND CLUBS AND IMPROVE THE STANDARD OF DARTS IN THE DISTRICT DURING THE WINTER MONTHS”.

#### **6) PROMOTION/RELEGATION**

AFTER A THOROUGH DISCUSSION WITH VARIOUS VIEWS EXPRESSED IT WAS DECIDED TO DEFER ANY VOTE UNTIL THE AGM 20<sup>TH</sup>.MAY 2008 WHEN PERHAPS A CLEARER IDEA OF THE NUMBER OF TEAMS WISHING TO PLAY NEXT SEASON WILL BE KNOWN.

#### **7) DART BOARD SURROUNDS.**

WE HAVE BEEN INFORMED BY OUR SUPPLIER THAT THE FOUR SURROUNDS ORDERED BY KEO SHOULD BE COMPLETED BY 19<sup>TH</sup>.JANUARY.

A MEETING WITH KEO WILL TAKE PLACE WHEN THE SURROUNDS ARE SUPPLIED AND THE QUESTION OF THE SUPPLY OF DART BOARDS AND THE TOTAL OR PARTIAL REIMBURSEMENT OF MONEY SPENT BY PUBS AND CLUBS WILL BE DISCUSSED.

## **8) FINANCE.**

WE HAVE NOW RECEIVED OUR CLUB REGISTRATION FORM A024607 WHICH WILL NOW ENABLE US TO OPEN AN ACCOUNT IN THE LEAGUE NAME. THIS REGISTRATION FORM WILL NEED TO BE RENEWED BY THE END OF MAY 2008. TO DATE THE TOTAL OF THE LEAGUE FUNDS ARE 1213 EURO.

## **9) INDIVIDUAL/PAIRS COMPETITIONS**

THE COMPETITIONS WILL PROGRESS AS PER THE RULES AND THE DATES ARE THOSE ON THE FIXTURE LIST.

## **10) CHALLENGE MATCHES.**

THE CAPTAIN AND VICE CAPTAIN OF ALL 1<sup>st</sup> DIVISION TEAMS WERE ASKED TO PUT NOMINATIONS FORWARD FROM DIVISION 1 MEMBERS FOR A CAPTAIN, VICE CAPTAIN AND TEAM ADMINISTRATOR (MANAGER) FOR CHALLENGE TEAM A.

THE CAPTAIN AND VICE CAPTAIN OF ALL 2<sup>nd</sup> & 3<sup>rd</sup> DIVISION TEAMS WERE ASKED TO PUT NOMINATIONS FORWARD FROM DIVISION 2/3 MEMBERS FOR A CAPTAIN, VICE CAPTAIN AND TEAM ADMINISTRATOR (MANAGER) FOR CHALLENGE TEAM B.

THE CAPTAIN AND VICE CAPTAIN OF ALL DIVISIONS TEAMS WERE ASKED TO PUT NOMINATIONS FORWARD FROM THE MEMBERSHIP FOR A CAPTAIN, VICE CAPTAIN AND TEAM ADMINISTRATOR (MANAGER) FOR A COMBINED LADIES TEAM FROM ALL 3 DIVISIONS.

THE PERSONS SELECTED FROM THE NOMINATIONS WILL THEN SELECT THEIR LEAGUE TEAMS TO REPRESENT PAFOS DARTS LEAGUE IN ALL CHALLENGE MATCHES.

## **11) RE-ARRANGED MATCHES.**

THE GAMES INVOLVING FLANAGAN'S HAVE BEEN ALTERED SO THAT THEIR FIXTURES DO NOT CLASH WITH COCKATOO'S.

AMENDED FIXTURES HAVE BEEN INFORMED TO THE TEAMS AFFECTED BUT ARE ALSO AVAILABLE ON THE LEAGUE'S WEBSITE.

## **12) NOTIFICATION OF SCORES**

TEAMS ARE REQUESTED TO TEXT TERRY THEIR RESULTS AS SOON AS POSSIBLE AFTER THEIR MATCH SO THAT HE CAN UPDATE THE WEBSITE.

## **13) RULE CLARIFICATION.**

RULE 6.9:- IT WAS PROPOSED THAT “*THE TOTAL MATCH WILL BE DRAWN BEFORE THE FIRST GAME TAKES PLACE*” SHOULD BE REMOVED AND REPLACED BY “SINGLES MATCHES WILL BE DRAWN AFTER THE DOUBLES HAVE BEEN COMPLETED”.

A VOTE WAS TAKEN FOR DIVISION ONE THE RESULT OF WHICH WAS 7 IN FAVOUR, TWO AGAINST AND TWO WHO ABSTAINED.

A VOTE WAS TAKEN FOR DIVISIONS TWO AND THREE THE RESULT OF WHICH WAS 19 IN FAVOUR AND FOUR AGAINST.

***THE RULE WILL NOW BE AMENDED.***

IT WAS AGREED THAT PLAYERS SELECTED MUST BE PRESENT AT THE TIME OF THE DRAW FOR THE SINGLE MATCHES OR THEY WILL FORFEIT THEIR GAME.

## **14) PLAYING OF NON-REGISTERED PLAYERS.**

THE PLAYING OF NON-REGISTERED PLAYERS IS NOT ACCEPTABLE AND ANY TEAM FOUND TO BE DOING THIS WILL HAVE POINTS DEDUCTED UNDER RULE 3.6

THERE IS NO NEED TO PLAY A NON-REGISTERED PLAYER AS HE OR SHE CAN BE SIGNED ON BEFORE THE START OF A MATCH AND THE CURRENT LEAGUE FEE OF 5 EURO HANDED IN WITH THE RESULT SHEET.

IF THE TEAM ALREADY HAS TWENTY PLAYERS REGISTERED THEN A PLAYER MUST BE DE-REGISTERED AND MAY NOT PLAY FOR THAT TEAM DURING THE REST OF THE SEASON.

IT WAS PROPOSED THAT EACH MEMBER NEXT SEASON WILL BE ASKED TO PROVIDE TWO PASSPORT SIZE PHOTOGRAPHS WHICH WILL BE INCORPORATED ON THE MEMBERSHIP CARD.

THIS WILL BE VOTED ON AT THE AGM IF THE COMMITTEE FEEL IT IS NECESSARY.
