#### **7) DART BOARDS AND SURROUNDS :-**

A MEETING WAS HELD AT KEO 0900 27<sup>TH</sup>.SEPTEMBER AND THEY HAVE AGREED TO BUY FOUR SURROUNDS AT £40 EACH INCLUDING FITTING AS SAMPLES.THEY WILL SUPPLY THEIR LOGO TO BE ATTACHED AND IF THEY ARE SATISFIED THEY WILL PLACE AN ORDER FOR THE REQUIREMENTS FOR THE WHOLE OF THE ISLAND AT £30 EACH OR THE EQUIVALENT IN EURO IN JANUARY 2008. JOHN TO BE ASKED TO MANUFACTURE.
